# CTEAP-Higher Education Program Information

## Creation & Purpose:



The Colville Tribal Education Assistance Program (CTEAP) was created by Resolution Number 1977-358 of the

Tribal Council for the purpose of assisting enrolled members of the Colville Tribes' who wish to pursue further education in institutions of higher learning, business and commercial schools, vocational/technical institutions, and technological schools. The education Assistance Program is intended to assist students enrolled either on campus or enrolled in extension courses or regionally and/or nationally accredited institutions. Graduate and Senior level students are considered priority funding.

## CTEAP

CTEAP funding is derived from Tribal revenue. CTEAP provides supplemental grants to enrolled Colville Tribal members in post-secondary vocational or liberal arts program attending a two or four -year college or university on a full or part-time basis.

## Higher Education

Higher Education is contracted from the Bureau of Indian Affairs with federal monies. Enrolled Colville Tribal members are eligible for supplemental grants in post secondary liberal arts program attending a two or four-year college or university. Must reflect financial need.



## Cecelia Somday Education Fund

The Cecelia Somday Education Fund was originated from Ms. Cecelia Somday the first year and the Colville Tribe continued to fund the program with Tribal revenues. Thirteen (13) scholarships, contingent upon funding, are awarded to enrolled Colville Tribal members.

## Cecelia Somday Primary Eligibility

Applicant must be an enrolled Colville Tribal member and have achieved a 3.0 grade point average for each of the last three quarters or last two semesters of school (high school or college). Applicant must submit two recommendation forms with application when they apply online. Incomplete applications will be deemed ineligible.

## Certificate- Degree Completion

Full-Time students must complete their certificate or degree within the time allowed:

- A. Two academic years plus one term (5 semesters or 7 quarters).
- B. Four academic years plus one term (9 semesters or 13 quarters).
- C. Graduate students must complete their program within institution guidelines.
